- He / She should have made outstanding and exceptional impact in the internal audit profession through research, education, publications, conferences, practice, speaking, innovative programs or other developmental activities. His/her contribution could be part of his/her career / job, as a volunteer with the IIA Local institute, as a volunteer with the ACIIA, or a combination of ALL 3.
- The candidate should have spent at a minimum, 15 years in the field of internal audit and should have impacted the practice of internal audit, advanced the awareness of local IIA Institute, ACIIA and inspired the profession around the Asia Pacific region.
- All Candidates must be willing to travel to the ACIIA CAE Leadership Forum in New Delhi, India on November 8-9 2017 to accept the award. *(The airfare and accommodation for the winner will be borne by ACIIA.)*
- Members of Executive Committee and staff of ACIIA shall not be eligible to receive this award, during their office tenure.
